- **2.** Winterization of Pavilion The pavilion at the park has been winterized, ensuring that it remains protected from the harsh winter conditions and is ready for use once the warmer months return.
- 3. Equipment Maintenance In response to the recent storms, light mechanical work was completed on trucks and plow equipment to ensure all vehicles are fully operational and ready for upcoming weather events.
- **4. Town Hall Lighting** The DPW crew has been working on lighting at the Town Hall, performing necessary repairs and upgrades to enhance visibility and safety.
- **5.** In-House Training In-house training sessions focused on safety protocols and work zone management have been conducted to ensure that all staff are well-prepared for working in various environments and maintaining a safe workplace.

- 6. Education Nicholas Brigante has passed his CDL class. Christopher Korbylo is enrolled in the course to obtain his CDL. I have passed the first of 3 sections of the CPWM course.
- 7. New Truck The new Dump Truck Cab and Chassis is in and the dump body and plow package upfit is being done at Henderson. Looking into getting a date of completion.

Linda Kabis stated that she has enjoyed EverGreen Park and EverGreen Trail with her seeing eye puppy and appreciate that dogs are allowed in the park and on the trail. ORDINANCE NO. 2024-12 TOWNSHIP OF GREEN, COUNTY OF SUSSEX, STATE OF NJ

AN ORDINANCE AMENDING GREEN TOWNSHIP CODE SECTION 8-103 "USE OF TOWNSHIP OWNED FACILITIES" REGARDING EVERGREEN PARK PAVILION RENTAL FEES

WHEREAS, the Green Township Committee has reviewed the use of the pavilion at EverGreen Park and has determined that revisions to the existing Code are necessary in order to revise the fees for use of the pavilion.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Green, Sussex County, New Jersey, that Section 8-103 of the Township Code is revised as follows.

SECTION 1. Section 8-103(a), Use of Township Owned Facilities, Fee Schedule, shall be revised only as to the Pavilion, by deleting the two lines in the current Code regarding "Pavilion" and replacing them as follows:

	Per ½ Day (less than 4 hours)	Per Day (greater than 4 hours)
Pavilion rental by resident	\$0	\$0
Pavilion rental by non-resident	\$75	\$100

SECTION 2. If any provision of this Ordinance or the application of this Ordinance to any person or circumstances is held invalid, the remainder of this Ordinance shall not be affected and shall remain in full force and effect.

SECTION 3. REPEALER

All ordinances or parts of ordinances or resolutions that are inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.

SECTION 4. EFFECTIVE DATE

This Ordinance shall take effect immediately upon adoption and publication in accordance with law.

(hereinafter "Andover," or "Provider")

and:

TOWNSHIP OF GREEN, a municipality of the State of New Jersey, having its office at 150 Kennedy Road, Tranquility, New Jersey 07879

(hereinafter "Green," or "Recipient");

together, hereinafter, the "Parties"

WITNESSETH:

WHEREAS, Green has a need for traffic enforcement services; and

WHEREAS, the Police Department of the Township of Andover has the capacity to provide traffic enforcement services; and

WHEREAS, Andover is willing to provide traffic enforcement services to Green; and

WHEREAS, the sharing of traffic enforcement services will benefit both Green and Andover by increasing the efficiency and decreasing the costs of those services; and

WHEREAS, in enacting the "Uniform Shared Services and Consolidation Act," <u>N.J.S.A.</u> 40A:65-1 et seq., the New Jersey Legislature has permitted municipalities to enter into agreements to provide or receive services to/from one another as a means to reduce municipal expenses; and

WHEREAS, accordingly, Green and Andover desire to enter into this Shared Services Agreement ("Agreement), through which the Police Department of the Andover shall provide traffic enforcement services for Green; and

WHEREAS, Andover has approved this Agreement pursuant to RESOLUTION #R2024-144 on December 5, 2024, and Green has approved this Agreement pursuant to RESOLUTION #2024-207 on December 16, 2024.

NOW, THEREFORE, IN CONSIDERATION OF the mutual promises, covenants and representations herein contained, the parties hereto, for themselves, their heirs, successors and assigns, hereby agree as follows:

I: SCOPE OF SERVICES

- 1. Andover, via the services of the Andover Police Department, shall provide traffic control services to Green under the terms and conditions as hereinafter set forth.
- 2. Andover agrees to provide police officer(s) and all equipment necessary to render traffic enforcement services (hereinafter, the "Services") within Green.
 - 3. Andover shall provide the Services beginning on December 20, 2024.
- 4. The Services will be provided by Andover at times and locations within Green as agreed upon between the Parties. Enforcement areas will be selected based on a variety of considerations including, but not limited to, visual deterrence, known or perceived violations, motor vehicle crash data, speed trailer surveys, citizen complaints and the professional knowledge and experience of the law enforcement officers involved.
- 5. The Services shall be provided under the sole and exclusive direction of the Andover Police Chief. No Green official will personally direct any operations of any Andover police officer.
- 6. The Andover Police Chief shall have flexibility in assigning police officers for traffic enforcement in Green. The Andover Police Chief may reassign Andover police officers assigned to traffic enforcement services in Green pursuant to this Agreement in the event that an emergency occurs within Andover requiring that all Andover police officers be assigned duties within Andover. Traffic enforcement service assignments in Green will resume as soon as practicable after the resolution of the emergency as determined by the Andover Police Chief.
- 7. It is expected that assignments will be made on days and at times that maximize the police officers' productivity. All Andover police officers assigned to provide traffic enforcement services within Green pursuant to this Agreement are expected to demonstrate productivity while providing such services. Productivity may be determined by motor vehicle stops/contacts, warnings, summonses issued, and any other professional standards used by law enforcement professionals to measure productivity as determined by the Andover Police Chief or his/her designee.

- 8. Andover police officers shall appear in Green Township Municipal Court as required to adequately prosecute any and all charges issued as the result of enforcement action taken by Andover officers while providing Services to Green. In the event that the Municipal Court orders an Andover police officer to appear in court in connection with a Green traffic enforcement matter at a time that cannot be scheduled by the Andover Police Department without incurring overtime, these costs will be covered by the terms of the Agreement. The Green Township Municipal Court Administrator will work with the Andover Police Chief or his designee to schedule court appearances by Andover police officers in connection with Green traffic enforcement matters so as to avoid the need for overtime pay for such appearances.
- 9. As necessary, Green Township shall readily grant to Andover officers full access to Green Township's systems & databases concerning traffic & criminal law matters.
- 10. Green shall provide no additional compensation for any law enforcement services provided by Andover within Green that are outside the scope of this Agreement. Andover police officers assigned to provide traffic enforcement services within Green who confront a law enforcement emergency while providing such services are expected to respond as required according to their professional training.
- 11. Andover shall provide approximately six (6) hours per week or 24 hours per month of traffic enforcement services (which includes required court time). Andover shall provide a minimum of 300 hours per year and a maximum of 310 hours per year of traffic enforcement services, inclusive of court appearances. The number of hours provided may be amended by mutual written prior consent by both parties.

II. TERM OF AGREEMENT

12. The term of this Agreement shall commence on December 20, 2024 and remain in effect until December 20, 2025, unless terminated sooner pursuant to the 'Termination' clause below. However, once six (6) months have transpired since the commencement date, Andover shall have a one-time option to cancel the Agreement for no reason, and incurring no penalty. The parties may agree in writing to renegotiate or extend this Agreement at the expiration of its initial term for additional one (1) year terms.

III. PAYMENT FOR SERVICES

13. Green shall pay Andover for Services at the rate of \$30,000.00 per year or \$7,500.00 per quarter, with payment to be rendered on or about March 1, June 1, September 1, and December 1, 2025. All costs associated with the traffic enforcement and court associated costs for the term of this contract shall not exceed \$30,000. Andover Twp Police Chief shall provide an accounting of the hours quarterly to Green Township to ensure that this amount is not exceeded annually

IV. REPORTS

14. When requested by Green, the Andover Police Chief or his/her designee will provide documentation of the hours, location, and productivity of the Andover police officers assigned to provide traffic enforcement services within Green pursuant to this Agreement.

V. INDEMNIFICATION

15. Green shall not be liable for any negligent, reckless or intentional acts or omissions of Andover and Andover shall indemnify, defend and hold Green harmless from all losses, injuries or damage caused by the negligent, reckless or intentional acts or omissions of Andover or any of its respective employees or independent contractors in rendering law enforcement services pursuant to this Agreement, including any allegations against Green arising out of the provision of police services. Such indemnification shall include payment of reasonable attorney's fees and costs in the defense of any claim made by a third person against Green incident to such neglect, reckless or intentional acts or omissions. Andover is not obligated to indemnify Green if the acts or omissions are exclusively that of Green.

VII. INSURANCE

16. The Andover police officers providing law enforcement services pursuant to this Agreement will be considered employees of Andover at all times, whether on Green property or Andover property. Andover will provide workers compensation, police professional liability, comprehensive general liability, motor vehicle insurance and errors and omissions insurance related to services provided by Andover police officers pursuant to this Agreement. Andover will cause Green to be named as an additional insured on the above polices on a primary, noncontributory basis.

VIII. APPLICABLE LAW

17. Each party shall comply with all applicable laws pertaining to the provisions of law enforcement services including, without limitation to the Uniformed Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq.

IX. TERMINATION

18. Either party may terminate this Agreement for any reason provided that the party seeking the termination provides a thirty (30) day written notice in advance of the date of the termination. Either party may terminate this Agreement in the event of a breach of the terms of this Agreement by the other provided that the party seeking the termination provides a ten (10) day written notice in advance of the date of the termination to allow for cure of the breach. This Agreement may be terminated at any time by written agreement of the parties.

X. ENTIRE AGREEMENT

19. This Agreement represents the entire agreement between the parties and may not be supplemented, amended or revised unless in writing and signed by the parties to the original agreement.

XI. SEVERABILITY

20. If any part of this Agreement shall be held to be unenforceable, the remainder of this Agreement shall remain in full force and effect.

XII. WAIVER

21. Failure to insist upon strict compliance with any of the terms, covenants or conditions of th.is Agreement at any time shall not be deemed a waiver of such term, covenant or condition at any other time; nor shall any waiver or relinquishment of any right or power herein at any time be deemed a waiver or relinquishment of the same or any other right or power at any other time.

RESOLUTION SUPPORTING AMENDMENT OF THE FAIR HOUSING ACT (FHA) AS PROPOSED BY THE NEW JERSEY INSTITUTE OF LOCAL GOVERNMENT ATTORNEYS (NJILGA)

WHEREAS, the current standards embodied in the New Jersey Fair Housing Act ("FHA") impose unrealistic burdens on municipalities as demonstrated by the fact that the FHA calls for the imposition of a statewide affordable housing obligation of 84,698 just for Round 4 on municipalities that issued only 99,956 Certificates of Occupancy for all housing units in the 2010-2020 period that was used to establish prospective need obligations for Round 4; and

WHEREAS, the imposition of unrealistic obligations does not create the realistic opportunity for the construction of more affordable housing; and

WHEREAS, the imposition of excessive obligations disincentivizes municipalities to comply voluntarily with the <u>Mount Laurel</u> doctrine – an overarching goal of all three branches of government; forces municipalities to overdevelop, thereby turning our Garden State into the garden apartment state; and places the cost of the obligation on the shoulders of taxpayers of municipalities, faced with the prospect of uncontrolled overdevelopment, are left no choice but to implement expensive compliance techniques; and

WHEREAS, even-handed justice requires that the obligations imposed by our laws must be realistic in order to justify imposing an obligation of constitutional dimension on municipalities to create a realistic opportunity for affordable housing; and

WHEREAS, the unrealistic obligations imposed by the current laws can be easily addressed by redefining the manner in which the regional need is calculated to be faithful to a principle embodied in the FHA despite its many changes over almost 40 years; and

WHEREAS, more specifically, the FHA has consistently defined the prospective need to include "a projection of housing needs based on development and growth which is *reasonably likely to occur* in a region or a municipality, as the case may be, as a result of actual determination of public and private entities" N.J.S.A. 52:27D-304 (j); and

WHEREAS, a determination of the number of new residential housing units, adjusted to remove tear down/rebuilds, represents a far more solid foundation to project "development and growth which is *reasonably likely to occur*" than the FHA's current formula, which is based on "household change"; and

WHEREAS, establishing prospective need for affordable units based on 20 percent of residential housing units actually constructed over a prior ten-year period accords with New

Jersey's long-standing policies of empowering municipalities to cure the abuse of exclusionary zoning with traditional inclusionary zoning; and

WHEREAS, the demand for market-rate housing is a reasonable basis for determining whether and to what extent a realistic opportunity for the creation of affordable housing may exist, and the issuance of certificates of occupancy for new residential units is a reliable indicator of such demand; and

WHEREAS, a standard aimed at ensuring that the number of affordable housing units in our state will increase commensurately with the number of market units constructed will put the doctrine on a sustainable trajectory that will avoid the doctrine from crumbling under its own weight by forcing municipalities to try to address overwhelming obligations; and

WHEREAS, the New Jersey Institute of Local Government Attorneys ("NJILGA") has expressed its support for an amendment to the FHA by which "development and growth which is reasonably likely to occur" would be based upon the net number of new housing units constructed over each ten-year period for which the state's affordable housing rounds are established; and

WHEREAS, for the above reasons, the Township Council of the Township of Green has determined that its prospective need, and the prospective need for all New Jersey municipalities for the fourth round and all future rounds of affordable housing obligations, should be calculated using NJILGA's proposed net housing unit/Certificate of Occupancy based methodology rather than the current FHA methodology based on "household change," and that NJILGA's proposed FHA amendment should be enacted by the New Jersey Legislature as soon as possible;

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Green, in the County of Sussex, State of New Jersey that the New Jersey Legislature is hereby requested to enact the amendment to the Fair Housing Act that has been recommended by the New Jersey Institute of Local Government Attorneys; and

WHEREAS, the Township of Green adopted Ordinance 2014-04 on April 28, 2014, adopting the "Township of Green Handbook Policies and Procedures" ("Handbook"), and providing that amendments and/or supplements to the Handbook may be made from time to time without notice and at the sole discretion of the Township Committee, which amendments and supplements shall be effective via Resolution; and

WHEREAS, the Township Committee adopted Resolution 2024-188 on November 24, 2024, amending the Handbook, specifically Section 5, Standards of Conduct, Breaks; and

WHEREAS, Township employees are scheduled to work 32.5 or 35 hours per week; and

WHEREAS, the Township Committee desires to further amend Section 5, Standards of Conduct, Breaks, to clarify the Handbook section.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Green, County of Sussex, State of New Jersey, that the Handbook shall be and is hereby revised and in effect from the date of adoption of this Resolution, as follows:

1. Section 5, Standards of Conduct, "Breaks", shall be revised to read as follows:

BREAKS

All full-time office employees (not covered by other agreement of law) shall have one thirty (30)-minute paid lunch daily from 12:00-12:30, during which time the municipal building shall be closed and employees shall be relieved of all work duties. Employees shall also take a 30-minute working lunch from 12:30-1:00 each day, during which time the employees must remain in the municipal building. Additionally, all employees are entitled to two (2) ten (10) minute paid breaks daily, one in the morning and one in the afternoon. The breaks shall be at the same time each day, as approved by the Township Clerk/Administrator. Lunch and break times cannot be combined. Breaks that are not utilized each day shall be forfeited. Supervisors and/or the Clerk/Administrator will schedule breaks for employees. Any change to scheduled break and/or lunch times must be approved by the Township Clerk/Administrator.
