FULLY FUNDED CAPITAL ORDINANCE TO PROVIDE FUNDING FOR THE PURCHASE OF ONE BOMFORD 3.4 ELECTRIC CONTROL AND

APPROPRIATING THE SUM OF \$24,000.00 FROM THE General Capital - Fund Balance FOR SAID PURCHASE

BE IT ORDAINED by the Township Committee of the Township of Green, County of Sussex, State of New Jersey, (not less than 2/3 of all members thereof affirmatively concurring) as follows:

SECTION 1. The Township Committee of the Township of Green hereby authorizes the following improvement:

a. The Township Committee of the Township of Green hereby authorizes the purchase of a Bomford 3.4 Electric Control, rear 3pt mount, 11' reach, 39" flail head from Storr Tractor Company, 3191 US 22 Branchburg, New Jersey, 08876, in the amount, not to exceed, \$32,006.40. Said purchase is authorized utilizing the Hunterdon County Educational Services Commission Contract CAT/SER -23-06.

The Township Committee appropriates the sum of \$24,000.00 from the Township's General Capital - Fund Balance (Account 04-215-55-914-020) for said acquisition.

The useful life of this equipment is at least five (5) years. No Supplemental Debt Statement is required since there is no authorization of any debt within this Capital Ordinance. The gross debt of the Municipality as defined by law is not increased by this ordinance, and no obligation in the matter of bonds or notes are authorized by this ordinance.

SECTION 2. This Capital Ordinance shall take effect immediately after publication following the final adoption as provided by law.
