#### **MINUTES:**

Approval of minutes of March 24, 2015:

Motion to approve the March 24th minutes was made by M. Viersma, with changes second by J.Wilson. All in favor, motion passed.

The Committee reviewed the Summary meeting minutes from the April 28<sup>th</sup> meeting. There was no quorum at this meeting.

#### **COMMUNICATION AND ANNOUCEMENTS:**

- M. Giacomantonio introduced himself to the Committee and expressed his interest in joining the Environmental Advisory Committee. M. Giacomantonio has lived in Green Township for 40 years and held Executive positions in fortune 500 companies. M. Giacomantonio owns 6 patents for environment safe products. M. Giaconmantonio turned in his application and C. Licata will forward to the Township Committee.
- C. Licata handed out Resolution 2015-59 to the Committee and read the appointments of M. Fox filling unexpired term of Chair, expiring December 31, 2015. M. Viersma will fill unexpired term (replacing G. Wershing), expiring December 31, 2015 and J. Wilson will fill unexpired term (replacing J. Wershing), expiring December 31, 2016.
- C. Licata handed out Resolution 2015-73 to the Committee and read the appointment of Dennis Walker to fill unexpired term Alternate 1, expiring December 31, 2016.

# **PLANNING BOARD/BOA BUSINESS:**

- The committee reviewed the minutes of the BOA meetings held on January 15, February 5, and April 2, 2015. The Committee has no comments at this time.
- M. Fox gave a brief update on the applications that are before the BOA. The Verizon cell
  tower project has been approved and is moving forward. M. Fox commented that the
  tower is only visible when traveling south on Route 519.

- J. Wilson gave an update on the application for a new dwelling on Shore Rd. The application for "c" variance and waivers to build a new dwelling has been approved.
- J. Wilson gave an update on Doggone Farm. The applicant has requested a 3 month extension. They are having trouble with the County Health Dept. updating 13 items in which they have requested. The application was given an additional 3 month extension with monthly updates to the Board on the progress.
