Scenic Drive and County Route 517 Discussion Continued – Mr. Rich Stein reviewed the survey. The long piece of property along Decker Pond Road was intentionally held back by Lake Tranquility Developers so that the

properties would not have direct access to County Route 517. Mr. Stein has tracked down the widow of the last known surviving shareholder officer and director of Lake Tranquility. A quit claim deed was filed and any rights are given to the Township. There has been very limited contact from the County to resolve the issue. In addition to the bushes in the county's right of way, the kiosk is another obstacle. There is no recorded license or documentation as to who owns the kiosk. Mr. Stein sent a letter to the local company that advertises on the kiosk asking for proof of rights and if there is no proof to remove the kiosk.

• Bid for Municipal Building Parking Lot and Garage—Mr. Miller reviewed the drawings at a recent Planning Board Meeting. The specs and plans are completed. Mr. Rich Stein has prepared two resolutions for the parking lot one with the prefab garage and one without the garage. - **d.** Trinca Airport Workshop Mr. Bilik discussed the possibility of selling the airport and using the funds to pay off the bond. One option would be to have an airport community including five homes having airport access. Another option would be to subdivide the non-airport parcel into two parcels into farmland preservation. There are companies that specialize in airport real estate. Mr. Bilik requested permission to make contacts to see if there is any interest in buying the property. At this time, Mayor Conkling accepted comments from Mr. Gene Bambara, 4 Old Forge Lane. Mr. Bambara suggested an alternate option for the property. A deed restricted 55 plus community would be beneficial and a good source of revenue for the town with no additional burden on the school. The Committee look at all options presented to them.

The Risk Manager, Mr. Wayne Dietz, has arranged for security and safety training from the company that dealt with the aftermath of the movie theatre shooting in Colorado. There are two sessions, day and evening, tentatively scheduled for September 16, 2013. The Committee further discussed security of the municipal building. Mrs. Phillips suggested waiting until the trainings next month as new ideas may be presented.

Swift 911 is an emergency service communication capable of notifying those that sign up to receive notifications via text, voice, email, facebook, twitter, etc. A proposal was submitted for \$2,450.00 per year.
