### AUTHORIZING AN EMERGENCY CONTRACT FOR THE PEQUEST ROAD – MILLING AND PAVING BID PROJECT

WHEREAS, an emergency has arisen with respect to an emergent condition requiring immediate paving due to emergent and unexpected repairs to drainage on either side of the tunnel on Pequest Road, which paving must be completed prior to snow plowing on this public road; and

WHEREAS, the DPW Supervisor has certified the emergency existed and remedial action is required for the paving to be completed prior to snowfall, and the need for such could not have been foreseen; and

WHEREAS, the Chief Financial Officer has certified the need to enter into an emergency contract to repair the road; and

WHEREAS, the Township may, in accordance with the Local Public Contracts Law (N.J.S.A. 40A:11-6 et seq.), negotiate or award a contract without public advertising for bids therefore, notwithstanding that the contract price will exceed the bid threshold, when such emergency affects the public health, safety or welfare; and

WHEREAS, give the emergent conditions, Township professionals sought prices, and C&V Paving Contractors was the lowest responsive bidder; and

WHEREAS, C&V Paving Contractors is able to respond to the emergency and provide the necessary paving, for a total contract price of \$44,800.00; and

WHEREAS, the Chief Financial Officer has certified that funds are available.

**NOW, THEREFORE, BE IT RESOLVED** that the Mayor and Township Committee of the Township of Green hereby approve and confirm the contract award for emergency services per N.J.S.A. 40A:11-6 et seq. to C&V Paving Contractors, in the amount of \$44,800.00.
