Overview:

Winter operations by the Department of Public Works (DPW) are currently in full swing. Crews have been actively engaged in snow removal, brush maintenance, and tree trimming tasks as weather conditions permit. Efforts are ongoing to ensure efficient service to the community while maintaining safety on roads and public spaces.

Key Activities:

1. Christmas Tree Pickup:

- o The Curbside Christmas Tree Pickup program, managed by DPW, is underway.
- o Pickup services are available from January 6th through January 31st.
- o Residents are reminded to place their trees at the curb for collection.

2. Brush and Tree Trimming:

o Crews are working on brush and tree trimming when the weather conditions allow.

3. Winter Equipment Maintenance:

- o Ongoing maintenance of winter operations equipment, such as snowplows and salt spreaders, is being performed after each snow event.
- o Ensuring that equipment is in optimal condition is a priority to guarantee a quick and effective response to winter weather challenges.

Tom Knutelsky newly appointed Township Engineer introduced himself to the Township Committee and thanked the Committee for the appointment. Tom will work closely with Cory Stoner to provide a greater level of engineering services.

Irene asked for an update on paving the roads in the Lake Tranquility section and is of the opinion that these roads are in far worse shape than the roads that have been recently paved. Mayor Raffay responded that the Township is actively taking into consideration and addressing the roads in Lake Tranquility. The Township Clerk added that the Township Committee has approved an RFP (Request for Proposals) to study the drainage. The RFP should be finalized and issued soon.

Mayor Raffay commented that the township roads recently paved were able to be done so with grant monies and are done because they are thruways. Phillips added that the funding was not available to do the drainage study. The Township Committee has now budgeted to do the drainage study.

Irene asked how the Master Plan Update works. The Township Attorney explained the process is done with the Land Use Board. A Public Hearing will be scheduled where the public will have the opportunity to review and provide input to the proposed revisions to the Master Plan.
