#### CALL TO ORDER

The May 13, 2013 meeting of the Green Township Committee was called to order at 6:12 p.m.

#### PLEDGE OF ALLEGIANCE

### **DISCUSSIONS:**

- a. Statewide Insurance Fund Safety Training Workshop on Ethics Mr. Ivan Cohen with Statewide Insurance Fund gave a brief presentation on ethics in the workplace. Mr. Wayne Dietz, Risk Manager followed up with additional comments. Code of Ethics and Conflict of Interest handouts are attached and made part of these minutes.
- b. Updates to Miscellaneous Projects Mr. John Miller Mr. Miller reviewed plans for the municipal parking lot using the same entrance since there is no benefit in the line of sight by moving the entrance further up the hill. The Committee made a few comments which Mr. Miller will incorporate into the plan. Mrs. Peralta mentioned additional handicapped parking spots near the lower side entrance are needed for Election Days. Overflow parking on court days needs to be considered also.

Suburban Consulting Engineers is putting the specifications together for 29 Hillside Terrace. Luna Chimney Sweeps inspected the wood stove and chimney. Their assessment is that the stove is not in compliance with code therefore, recommend installing a new one. The Committee recommends removing the wood stove. The electrical inspector inspected the panel which is ok. The inspector recommends exploring a forced hot air furnace system. Mr. Miller will prepare estimates and hope to have available for the next meeting.

Mr. Miller and Mr. Perigo looked at the roofs at Trinca Airport, Greendell and Tranquility Post Offices. Mr. Miller reviewed estimates of repairs to each building. After discussion, the Committee authorized Mr. Miller to obtain bid specs. This can be funded through capital budget through a fully funded ordinance.

The NJDEP Dam Safety mandates a desktop emergency exercise for Class I dams which would go through scenarios should there be an emergency at the Lake Tranquility dam. This should be done by the next dam inspection.

Mr. Bilik mentioned he was made aware of kids jumping off the bridge into the lake. There are signs posted at the bridge that state No Fishing, No Swimming, No Skateboarding, etc.

Mr. Miller informed the Committee the Township has been awarded a grant for Whitehall Road.

c. COAH Authorizes Taking of Municipal Housing Trust Funds – Mr. Stein explained the Governor abolished COAH. There are suits going through the courts now and pending before the Supreme Court whether he can do this or not. The Governor adopted a resolution authorizing all uncommitted monies collected by municipalities in their trust funds return to the State by May 22. Mr. Stein and Mrs. Peralta have been discussing with Mr. Vito Gallo. Mr. Stein recommended the Committee formally appeal the order from COAH to turn the monies over to the State.
