MATTERS FROM THE TOWNSHIP CLERK: Mr. Zschack noted the following matters:

<u>Rail Trail</u> - As the pursuit to extend the County Connector Rail Trail to the south is ongoing there is also a need to extend the trail northward. The current plan is to rent equipment in May and have Mr. Perigo clear the trail from Creek Road to Airport Road. Once completed bids will be solicited to construct the walking path.

<u>Forest Management</u> - On April 4, 2021, the Township Committee received an email concerning three new forest management bills. The bills would require municipalities to prepare and implement a Forest Stewardship plan for any wooded property over 25 acres. A quick review indicates that the Township owns two properties that will be affected by these regulations (EverGreen Trail & Highland Avenue properties). We will further research these bills and return with a recommendation.

<u>Golf on Municipal Property</u> - The Township received a complaint from a resident concerning the hitting of golf balls in EverGreen Park. No reference forbidding said action in the municipal code could be found. If the Township Committee agrees, what would be the process to ban said activity? After discussion, the Committee agrees to prohibit hitting golf balls at EverGreen Park.

<u>Petitions for Municipal Office and Party County Committee</u> - The deadline to submit a petition for Municipal office and County Committee was today at 4:00 p.m. The Green Township Clerk's office has received one petition for Township Committee for a three-year term as a Republican and zero from any Democratic candidate. Also received were one petition for Democratic Member of County Committee and eight petitions for Republican County Committee.

MATTERS FROM THE GOVERNING BODY: Mayor Phillips stated they are still waiting to hear from Altice and Optimum. Altice indicated that they will have an expansion phone number for residents to call.

With regards to COVID cases in Sussex County are the worst in the State right now. Mayor Phillips asked everyone to continue to be diligent and be safe.

Mr. Conkling asked about patch on Whitehall Road done by Elizabethtown Gas. Mr. Perigo explained that the Township Engineer feels that since Whitehall Road will be repaved this year, the current patch is sufficient.

ORDINANCE NO. 2021-08

TOWNSHIP OF GREEN, COUNTY OF SUSSEX, STATE OF NEW JERSEY

AN ORDINANCE REQURING PROPERTY OWNERS TO REMOVE AND CLEAR SNOW AWAY FROM FIRE HYDRANTS

WHEREAS, in 2016, the State of New Jersey passed a law that allows local governments to require property owners to clear snow away from a fire hydrant near their home within 24 hours after a snowstorm or face a fine of as much as \$75.00; and

WHEREAS, the Township Committee desires to specifically adopt a new section 17-2.7.1 "Removal of Snow Around Fire Hydrants" of the Green Township Code.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of Green Township, Sussex County, New Jersey, that a new Section 17-2.7.1 shall be adopted as part of the Green Township Code, regarding the removal of snow from and around fire hydrants on any real property in the Township of Green, as set forth herein:

SECTION 1.

A new Section 17-2.7.1 shall be adopted as follows:

§ 17-2.7.1 Removal of Snow Around Fire Hydrants

The owner, owners or lessees of any real property in the Township abutting any fire hydrant shall maintain the area within a five (5) foot radius of the perimeter of any such fire hydrant free of snow. The removal of snow shall be completed within twenty-four (24) hours of daylight after the snow has formed or fallen or accumulated on or around any fire hydrant. Failure to perform the required clearance within the specified time frame, the Township, or any department thereof, may perform the clearance and bill the responsible party no more than \$75.00.

SECTION 2 - SEVERABILITY

If any provision of this Ordinance or the application of this Ordinance to any person or circumstances is held invalid, the remainder of this Ordinance shall not be affected and shall remain in full force and effect.

SECTION 3 - REPEALER

All ordinances or parts of ordinances or resolutions that are inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.

SECTION 4: EFFECTIVE DATE

This Ordinance shall take effect immediately upon adoption and publication in accordance with law.

ORDINANCE NO. 2021-09 TOWNSHIP OF GREEN, COUNTY OF SUSSEX, STATE OF NJ

AN ORDINANCE BY THE TOWNSHIP OF GREEN DELETING SECTIONS 30-50.3(h) AND 30-82.18 OF THE TOWNSHIP CODE AND PROHIBITING THE OPERATION OF ANY CLASS OF CANNABIS BUSINESSES WITHIN ITS GEOGRAPHICAL BOUNDARIES

WHEREAS, in 2020, New Jersey voters approved Public Question No. 1, which amended the New Jersey Constitution to allow for the legalization of a controlled form of marijuana called "cannabis" for adults at least 21 years of age; and

WHEREAS, on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the recreational use of marijuana by adults 21 years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational (adult use) cannabis operations, use and possession; and

WHEREAS, the Act establishes six marketplace classes of licensed businesses, including:

- Class 1 Cannabis Cultivator license, for facilities involved in growing and cultivating cannabis;
- Class 2 Cannabis Manufacturer license, for facilities involved in the manufacturing, preparation, and packaging of cannabis items;
- Class 3 Cannabis Wholesaler license, for facilities involved in obtaining and selling cannabis items for later resale by other licensees;
- Class 4 Cannabis Distributer license, for businesses involved in transporting cannabis plants in bulk from on licensed cultivator to another licensed cultivator, or cannabis items in bulk from any type of licensed cannabis business to another;
- Class 5 Cannabis Retailer license for locations at which cannabis items and related supplies are sold to consumers; and
- Class 6 Cannabis Delivery license, for businesses providing courier services for consumer purchases that are fulfilled by a licensed cannabis retailer in order to make deliveries of the purchases items to a consumer, and which service would include the ability of a consumer to make a purchase directly through the cannabis delivery service which would be presented by the delivery service for fulfillment by a retailer and then delivered to a consumer.

WHEREAS, the Act authorizes municipalities by ordinance to adopt regulations governing the number of cannabis establishments (defined in Section 3 of the Act as "a cannabis cultivator, a cannabis manufacturer, a cannabis wholesaler, or a cannabis retailer"), cannabis distributors or cannabis delivery services allowed to operate within their boundaries, as well as the location manner and times operation of such establishments, distributors or delivery services, and establishing civil penalties for the violation of any such regulations; and

ORDINANCE 2021-09 TOWNSHIP OF GREEN, COUNTY OF SUSSEX, STATE OF NJ

WHEREAS, the Act authorizes municipalities by ordinance to prohibit the operation of any one or more classes of cannabis establishments, distributors, or delivery services anywhere in the municipality; and

WHEREAS, the Act also stipulates that any municipal regulation or prohibition must be adopted within 180 days of the effective date of the Act (i.e., by August 22, 2021); and

WHEREAS, the failure of a municapility to act shall mean that for a period of five years thereafter, the growing, cultivating, manufacturing, selling and reselling of cannabis and cannabis items shall be permitted uses in all industrial zones, and the retail selling of cannabis items to consumers shall be a conditional use in all commercial and retail zones; and

WHEREAS, at the conclusion of the initial and any subsequent five-year period following a failure to enact local regulations or prohibitions, the municipality shall again have 180 days to adopt an ordinance regulating or prohibiting cannabis businesses, but any such ordinance would be prospective only and would not apply to any cannabis business already operating within the municipality; and

WHEREAS, the Township Committee of the Township of Green has determined that, due to present uncertainties regarding the potential future impacts that allowing one or more classes of cannabis business might have on New Jersey municipalities in general, and on Green Township in particular, it is at this time necessary and appropriate, and in the best interest of the health, safety and welfare of the Township's residents and members of the public who visit, travel, or conduct business in Township of Green, to amend the Township's zoning regulations to prohibit all manner of marijuana-related land use and development within the geographic boundaries of Green Township; and

WHEREAS, officials from two prominent non-profit organizations that have been established for the purpose of advising New Jersey municipalities on legal matters such as have been presented by the Act (those organizations being the New Jersey State League of Municipalities and the New Jersey Institute of Local Government Attorneys) have strongly urged that, due to the complexity and novelty of the Act; the many areas of municipal law that are or may be implicated in decisions as to whether or to what extent cannabis or medical cannabis should be permitted for land use purposes or otherwise regulated in any particular municipality; and the relatively short duration in which the Act would allow such decisions to be made before imposing an automatic authorization of such uses in specified zoning districts subject to unspecified conditions, the most prudent course of action for all municipalities, whether or not generally in favor of cannabis or medical cannabis land development and uses, would be to prohibit all such uses within the Act's 180-day period in order to ensure sufficient time to carefully review all aspects of the Act and its impacts;

NOW THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Green, County of Sussex, State of New Jersey, as follows:

Section 1. Pursuant to the New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act (P.L. 2021, c. 16), all cannabis establishments, cannabis distributors and/or cannabis delivery services are hereby prohibited from operating anywhere in the Township, except for the delivery of cannabis items and related supplies by a delivery service.

ORDINANCE 2021-09 TOWNSHIP OF GREEN, COUNTY OF SUSSEX, STATE OF NJ

Section 2. Section 30-59 of the Township Code of the Township of Green is hereby amended by adding the following:

"All classes of cannabis establishments or cannabis distributors and/or cannabis delivery, but not the delivery of cannabis items and related supplies by a delivery service, are prohibited in all zoning districts."

- **Section 3.** Section 30-50.3, "Conditional Uses", delete subsection (h) "Medical Marijuana Growing, Production and Manufacturing in the AI-10 Zone Only" in its entirety.
- **Section 4.** Section 30-82.18, Medical Marijuana Growing, Production and Manufacturing in the AI-10 Zone Only" is deleted in its entirety.
- **Section 5.** Should any section, paragraph, sentence, clause or phrase of this Ordinance be declared unconstitutional or invalid for any reason by any Court of competent jurisdiction, such provision(s) shall be deemed severable and the remaining portions of this Ordinance shall remain in full force and effect.
- **Section 6.** All ordinances or parts of ordinances or resolutions that are inconsistent with the provisions of this Ordinance are repealed to the extent of such inconsistency.
- **Section 7.** The Township Clerk is directed to give notice at least ten days prior to the hearing on the adoption of this Ordinance to the County Planning Board and to all others entitled pursuant to the provisions of N.J.S.A. 40:55D-15. The Township Clerk is further directed to refer this Ordinance to the Township Land Use Board, pursuant to N.J.S.A. 40:55D-64. Upon the adoption of this Ordinance, after public hearing, the Township Clerk is further directed to publish notice of the passage and to file a copy of this Ordinance, as finally adopted, with the Sussex County Planning Board, as required by N.J.S.A. 40:55D-16.
- **Section 8.** This Ordinance shall take effect after publication and passage according to law.

SUPPORTING S-3522 CREATING LOCAL PART OF THE PUBLIC EMPLOYEES' RETIREMENT SYSTEM (PERS)

WHEREAS, county, municipal, and other local governments have met their pension obligations as employers for more than a decade while the State of New Jersey has continued to underfund the pension systems in varying degrees since 1996 and thus created one of the worst publicly funded retirement systems in the entire nation; and,

WHEREAS, despite fulfilling their fiduciary duties in meeting their pension obligations, local governments across the State will experience double digit percentage increases in total employer pension contributions in 2021 as determined in figures recently published by the Division of Pension and Benefits in the State Department of Treasury; and,

WHEREAS, even more alarming for local government employers is the fact that the unfunded accrued liability once again increased in 2021 to a staggering \$26.6 billion for the Public Employee's Retirement System ("PERS") alone, causing in part, a decrease in the funded ratio for the Local Part of PERS to 65.4%, the State Part to 31.2%, and the combined rate to a disconcerting 52.2% far below the target funded ratio of 75.0%; and,

WHEREAS, S-3522 would divide PERS into two parts: A State Part for State employees, and a Local Part for all other employees; and

WHEREAS, the legislation creates a seven-member board consisting of three labor employee representatives, three management representatives, and one determined by the Board, tasked with operating the retirement system and directing policies and investments to achieve and maintain full funding; and

WHEREAS, this legislation is similar to the legislation that separated the Police and Fire Retirement System (P.L. 2018, c. 55) except for the control of investments and that management has an equal representation on the board, which was overwhelmingly supported by the legislature and signed by the Governor; and

WHEREAS, S-3522 would protect local governing bodies from the State of New Jersey further directing property taxpayer dollars to subsidize its long mismanagement and underfunding of the pension systems as it would provide the new balanced board of trustees of PERS with the ability to determine or modify member benefits, direct policies and investments to achieve full funding, and serve as fiduciary of the system;

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Green, in the County of Sussex and State of New Jersey does in fact hereby support S-3522, which would establish a new board of trustees for the Local Part of PERS to preserve the structure and integrity of the more solvent Local Part.
