## RESOLUTION 2021-185 TOWNSHIP COMMITTEE - TOWNSHIP OF GREEN COUNTY OF SUSSEX, STATE OF NJ

### **EMERGENCY MEETING**

WHEREAS, this emergency meeting has been called for the following purpose: to enter into Executive Session to discuss: Litigation - Frelinghuysen v Green Township and Green Township Volunteer Fire Department; and

WHEREAS, the normal requirements of the law regarding 48 hours notice have not been met due to lack of time and subject matter, however notices of this Emergency Meeting were emailed to the New Jersey Herald on December 10, 2021; and

WHEREAS, there is a court hearing schedule for December 22, 2021 for a preliminary injunction in the pending litigation *Frelinghuysen v Green Township and Green Township Volunteer Fire Department*, where Plaintiff will seek, *inter alia*, an order compelling Green Township and the Green Township Fire Department to continue to provide various fire-related services and equipment pending the court's ultimate disposition of the matter at a later date;

WHEREAS, the parties to the above-referenced litigation wish to extend the return date for the preliminary injunction so they have sufficient time to negotiate and agree to settlement terms, thereby removing this matter from the jurisdiction of the court and avoiding the legal fees that the parties would otherwise incur by fully briefing and arguing this matter on December 22, 2021;

WHEREAS, this emergency meeting is necessary because Plaintiff will not agree to maintain the status quo of its relationship with the Defendant parties during the above-referenced negotiation period, and, instead, Plaintiff insists on providing a lower monthly payment of \$2,000, which was communicated to Green Township through counsel for Plaintiff on December 10, 2021;

WHEREAS, if the Township were to delay this meeting, there would likely be substantial harm to the public interest since the parties would incur unnecessary legal fees and not have sufficient time to present this complex matter to the court.

WHEREAS, the need for such adequate notice could not reasonably have been foreseen at a time when adequate notice could have been provided

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Green, in the County of Sussex, and State of New Jersey, that there should be a vote on this Emergency Meeting of 3/4ths of the members of the Governing Body.
