UNFINISHED BUSINESS:

1. Update on County Connector Trail - Mr. Caruso stated that he and Mr. Conkling met with the Township Engineer, Mr. Cory Stoner; the DPW Supervisor, Mr. Watson Perigo; and the Township Clerk/Administrator, Mr. Mark Zschack to discuss the surface of the trail. Mr. Stoner will put together a bid package for the surface to be completed as Phase I on the trail from County Route 611 to Creek Road. The plan is for a 10-foot wide path. DEP approvals will be needed to connect the trail from Creek Road to the tunnel on Whitehall Road. The official opening will be planned for Green Township Day, September 22, 2018.

NEW BUSINESS: Mr. Caruso stated that two parcels in Green Township are showing interest in farmland preservation.

COMMENTS FROM THE OPEN SPACE COMMITTEE: Mr. Nusbaum complimented the new kiosk at the entrance of the trail and suggested a plexiglass coverage overhead.


PUBLIC COMMENTS and/or QUESTIONS: No public were present

EXECUTIVE BUSINESS: None


