AN ORDINANCE ESTABLISHING AN ELECTRIC AND/OR NATURAL GAS AGGREGATION PROGRAM

WHEREAS, the State of New Jersey has been engaged in a process to establish a competitive market place through deregulation and restructuring the electric utility market and/or natural gas market; and

WHEREAS, the establishment of a government aggregator and an energy aggregation program to purchase electric generation service and/or natural gas pursuant to N.J.S.A. 48:3-93.1 et seq. and N.J.A.C. 14:4-6.1 et seq. will increase competition for the provision of electric power and/or natural gas to residential and non-residential users, thereby increasing the likelihood of lower electric rates and/or natural gas rates for these users without causing any interruption in service; and

WHEREAS, under the aggregation process the residential and non-residential ratepayers may likely receive a direct reduction in their electric and/or gas bills; and

WHEREAS, the realization of energy cost savings is in the interests of the health, safety and welfare of the residents and non-residents of the Township of Green; and

WHEREAS, the Township of Green hereby finds that is in the best interests of residential and non-residential ratepayers for the Township of Green to create the opportunity for them to enter into an aggregation agreement in order to seek substantial savings on electric and/or natural gas rates; and

NOW, THEREFORE BE IT ORDAINED, by the Township of Green in the County of Sussex and the State of New Jersey, duly assembled in public session, as follows:

- 1. The Township of Green publicly declares its intent to become an aggregator of electric power on behalf of its residential users of electricity pursuant to the Government Energy Act of 2003, **N.J.S.A.** 48:3-91.3 to -98, and implementing regulations.
- 2. The Township of Green will utilize approved vendors, Concord Engineering's dba Concord Energy Services and Commercial Utility Consultants, Reverse Energy Auction Platform pursuant to the NJ E-PROCUREMENT Pilot Program (P.L. 2001, c.30) under the NJ Department of Community Affairs. The Reverse Energy auction will seek bids from licensed and appropriate third party suppliers. If such winning bid is selected and agreement executed, individual residential consumers would retain the option not to participate and to choose any alternatives they desire.
- 3. The Mayor and Township Clerk are hereby authorized and directed to execute any documents necessary to carry out the purpose of the ordinance.
- 4. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.

AN ORDINANCE CREATING SECTION 2-41, "AGRICULTURAL ADVISORY COMMITTEE" OF THE CODE OF THE TOWNSHIP OF GREEN

WHEREAS, the Township of Green recognizes that an Agricultural Advisory Committee can benefit residents of the Township by assisting the Township Land Use Board and Township Committee in protecting and maintaining the beneficial character of agriculture and the Farmland Preservation Plan element; and

WHEREAS, the Township of Green is empowered to establish an Agricultural Advisory Committee pursuant to N.J.S.A. 4:1C-43.1b (2); and

WHEREAS, an Agricultural Advisory Committee is necessary in order for Green Township to be eligible for municipal Farmland Preservation Planning Incentive Grants, pursuant to N.J.A.C. 2:76-17A.3;

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Green in the County of Sussex and the State of New Jersey, that a new Section 2-41 shall be adopted.

SECTION 1 - A new Section 2-41 shall be adopted as follows:

2-41 AGRICULTURAL ADVISORY COMMITTEE

- 2-41.1 Establishment. There is hereby established an Agricultural Advisory Committee which shall consist of three members who shall be residents of Green Township, in accordance with and with the powers as hereinafter set forth. The Agricultural Advisory Committee shall report to the Green Township Land Use Board and shall serve as an advisory committee to the Township Committee for the purposes of discussion of matters of interest to the farming community, current and pending Township ordinances affecting the farming community, farmland preservation planning, and other issues of interest to the farming community which will have an impact upon the Township as a whole.
- 2-41.2 <u>Membership</u>. Members shall be appointed by the Mayor with the consent of the Committee. The Agricultural Advisory Committee shall be comprised of three residents of the municipality; and the majority of the members must be actively engaged in farming and own a portion of the land that they farm.

The Agricultural Advisory Committee shall select from among its members a Chairman. The Committee shall also select a Secretary whose function shall be to maintain minutes of the Committee's meeting and records of the proceedings of the Committee.

- 2-41.3 Terms of Office. The terms of the members shall be for three (3) years.
- 2-41.4 Powers and duties. The Agriculture Advisory Committee shall:
 - A. Assist the Township Committee in carrying out its duties and responsibilities by informing it of developments in the farming community that should be considered when using municipal regulatory and land use powers.
 - B. Assist the Township Committee in development and review of ordinances for impacts upon the farming community.
 - C. Assist the Land Use Board in the review, adjustments and amendments to the Farmland Preservation Plan element pursuant to N.J.S.A. 40:55D-28b(13).
 - D. Consider educational opportunities for residents to learn about the history of farming in Green Township, how to support the local farming community, and how to become involved in the agricultural industry.
 - E. Promote interest in Township children in 4-H and other related agricultural activities.
 - F. Provide information to the Township's Open Space Committee on farmland preservation opportunities in Green Township.
 - G. Review and recommend any changes to Farmland Preservation Planning Incentive Grant (PIG) project areas or recommend new project areas to the Township Committee and Open Space Committee.
 - H. Make an annual report to the Township Land Use Board and Committee summarizing the activities and operations of the Committee during the preceding year.
- 21-4.5 <u>Public meetings</u>. The Agriculture Advisory Committee shall hold public meetings as it deems necessary, which public meetings shall be held in accordance with the Open Public Meetings Act, <u>N.J.S.A.</u> 10:4-6 et seq.
- 21-4.6 <u>Organization meeting</u>. The Agriculture Advisory Committee shall hold its initial organizational meeting within 60 days of the effective date of this Section.

SECTION 2 - SEVERABILITY

If any provision of this Ordinance or the application of this Ordinance to any person or circumstances is held invalid, the remainder of this Ordinance shall not be affected and shall remain in full force and effect.

SECTION 3 - REPEALER

All ordinances or parts of ordinances or resolutions that are inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.

WHEREAS, under a GEA Program the residential ratepayers may have the opportunity to receive a direct reduction in their electric bills through the bulk purchase of energy from a third-party energy supplier; and

WHEREAS, pursuant to an ordinance adopted by the Township of Green on April 3, 2017, the Township publicly declared its intent to commence a GEA Program by participating in the Sussex-Warren Area Energy Cooperative ("SWEAC"); and

WHEREAS, the Township of Fredon is the Lead Agency for the SWEAC and shall accept or reject pricing on behalf of the Cooperative and its participant members; and

WHEREAS, as a participating member of the program, Green Township hereby agrees to proceed with the program, by signing the Supplier Agreement, should the Township of Fredon accept pricing, which provides a savings on the supply portion of the electric bill for the residential energy aggregation program; and

WHEREAS, the Township of Fredon appointed Concord Energy Services for the SWEAC to serve as Energy Agency to assist and administer the GEA program at no cost to the Township of Fredon or SWEAC participating members; and
